Prepare for Launch: 2025 LSA Mission Briefing

Mission Control is officially prepping for liftoff! The 2025 Laboratory Self Audit (LSA) launches on August 1. This essential mission ensures that every lab space is equipped for safe and compliant operations before the fall research season begins in full force. Think of the LSA as your preflight checklist, confirming that critical safety systems are in place and ready for anything the semester may launch your way.

The LSA is a self-assessment that gives each lab crew the chance to identify potential hazards, confirm core safety measures, and course-correct where needed. Whether you're piloting one space or commanding a multi-lab operation, this year's improvements make participation smoother and more mission-ready than ever:

🗱 What's New This Cycle



- Advance Notification: A list of all required spaces has been shared ahead of launch to reduce confusion and allow for early planning.
- Prep Tools: Use the full survey preview and walkthrough checklist to gather your data and fine-tune operations before submitting.
- Streamlined Submissions: Got multiple spaces? You'll receive auto-filled links for each to make re-entry a breeze.

Each space listed must complete its own LSA. If multiple groups share a lab, each group must submit separately to ensure full crew accountability. Submissions are due by October 31.

If you've already taken off, great, keep cruising and reach out if turbulence hits. And if you didn't receive the
