This month, take a look at your workspace and see where you fall. Are you keeping hazards at bay while spreading holiday cheer, or sneaking down the chimney of risky behavior?

Naughty 🐯 or Nice 😇 Checklist

Lab Practices

- 🔯 : Leaving uncapped containers, unlabeled bottles, or spills unattended.
- 😇 : Capped contains proper labeling, secondary containment, tidy benches, and prompt spill clean-up Chemical Storage

- 🔯 : Storing incompatible chemicals together, ignoring expiration dates, or letting unknowns pile up. 😇 : Segregating chemicals by class, checking expiration dates, and keeping an updated chemical inventory.
- Electrical Safety

🔯 : Daisy-chaining extension cords, cords crossing aisles creating tripping hazards, or overloading outlets.

- 😇 : Using approved power strips, unplugging equipment when not in use, and keeping cords organized and away.
- Housekeeping & Facilities

🔯 : Blocking exits, fire extinguishers, or eyewash stations; leaving clutter in hallways.

- 😇 : Clear pathways, accessible safety equipment, and consistent cleaning.
- PPE & Behavior

🔯 : Skipping PPE or just wearing long sleeves or long pants. 😇 : Always wearing proper PPE and using a lab coat in addition to the covered limbs.

Behind the Scenes at EH&S: Year-End Highlights *

supporting research, academics, operations, and the FIU community. Here is a look at the impact our programs have made across campus. <u>Safety Education and Public Outreach</u>: EH&S proudly represented FIU on the national stage through CSHEMA,

where we presented maximizing outreach and earned three awards for innovation, process improvement, and marketing. We celebrated National Safety Month with contests, tabling sessions, and online engagement. Our team reached more than 488 new employees through bi-weekly New Employee Experience sessions and recognized ten outstanding Panthers through Safety Shout Outs. Training efforts reached more than 25,000 online module completions and over 500 attendees in instructor-led classes. Throughout the year, we responded to 138 health and safety concerns and expanded awareness efforts across multiple platforms. <u>Environmental Compliance:</u> To strengthen stormwater awareness, EH&S hosted volunteer events, distributed


educational materials, and supported the FIU Sustainability Fair. Our team conducted 89 compliance inspections and partnered with Facilities Management to improve stormwater and storage tank compliance processes. Fire Prevention and Life Safety: EH&S transitioned to CampusOptics to better track fire safety assets, drills, and

inspections. Between July 2024 and August 2025, our team completed 77 plan reviews, 182 event inspections, 53 permits, 78 emergency responses, and provided more than 700 hours of fire safety support. General Safety: Using CampusOptics, we enhanced inspection tracking and shifted our training focus to reduce

slips, trips, and falls. We completed 117 injury investigations, implemented 57 corrective actions, and

conducted 25 safety inspections. Our team also documented 64 indoor air quality assessments. <u>Laboratory Safety</u>: CampusOptics now supports our inventory system, waste requests, inspections, and lab management. A successful beta test helped refine the platform ahead of the July 2025 rollout. The 2024 LSA

reached 608 participants, supported by stronger campaigns and leadership involvement. EH&S also hosted a DCM Open Forum, coordinated DCM monitoring resources, and completed more than 689 lab inspections, 65 research proposal reviews, 313 surveillance clearances, 1,346 hazardous waste pickups, and 324 research approvals.
